TERMS AND CONDITIONS OF REGISTRATION

- The Re-Registration of a dog must be undertaken before 31st July or a penalty charge will be applied.
- Dogs over the age of 6 months must be registered.
- A Kennel Licence will be required if the owner keeps on a premises:
 - a) more than 2 dogs over the age of 6 months; or
 - b) more than 3 working dogs over the age of 6 months.Application forms are available at the Municipal Offices.
- **Pensioner Rate:** - The pensioner rate applies to one dog only, (owned by a pensioner), and as such, the Pensioner Concession Card MUST be produced when payment is made.
- **Desexed Dogs:-** Owners who wish to claim an initial deduction on Registration Fees for desexed (spayed or neutered) dogs must produce a veterinarian certificate as proof or sign an appropriate Statutory Declaration.
- **Micro-Chipping of Dogs:-** All dogs over 6 months of age must be micro-chipped (excluding specified racing greyhounds, all working dogs and hunting dogs tattooed by an approved organisation before 1 July 2011).
- **Change Of Circumstances:-** Council must be notified in the event of the death or change of ownership of the dog.
